President-Elect - (1) one year prior Board service required, (3) Year Commitment: President-Elect, President, Chairman of the Board):

The President-Elect shall oversee and assist with the fundraising efforts for special events and activities and such other further duties as may be assigned by the Board. The President-Elect shall, in the absence of disability of the President, perform the duties and exercise the powers of the President. Upon the completion of the term of the President, the President-Elect shall automatically (without an election) succeed to the office of the President and shall assume all of the duties assigned to the President.

2nd Vice President, VP of Meetings - (1) one-year prior Board service required:

The 2nd Vice President shall act and perform such duties and responsibilities as assigned by the Board, including the location, presentation, and implementation of programs for regular meetings. The 2nd Vice President shall act and assume the duties of the President in the absence of the President, President-Elect, and 1st Vice President.

Director (7) Seven Positions Available (2-Year Term):

- There shall be a total of twelve (12) Directors. Directors will be required to chair at least one monthly meeting during the year and will be required to co-chair and serve on at least one additional committee. Attendance at monthly board meetings and monthly LVHA meetings is required. Their duties shall be at the direction of the President-Elect and 2nd Vice President.

Eligibility: All elected officials; Appointees to the Board of Directors and members of The Board of Directors shall be active members in good standing. Elections will be held online and at the **LVHA November 2022 event**. Details to be announced.
